Mr. Valdez talked about solutions to the goose problem at Hollydot Golf Course, Lake Beckwith and Greenhorn Meadows Park. Since the geese are protected, the answer is a complicated one. The best known solution is trained dogs to chase the geese, but at this time, none are known of in the area.

Mr. Valdez told the board CCMD Parks and Recreation had received the planning grant from Great Outdoors Colorado. Work will done repairing the trail around Lake Beckwith, as well as plans for future trails.

11. OLD BUSINESS

Mr. Valdez stated work was being done about the Town of Rye. CCMD and Rye have both approved their arbitrators, a third independent arbitrator needs to be picked. The judge has ruled that the readings from the original meter should be used for billing purposes.
