Mr. Valdez said new water restrictions may be in place by the first of July. The new restrictions will be watering only 2 days a week. The wells will be turned on for the golf course. Lake Beckwith top fill level in 2013 has been 13'5" while last year it filled to 16'.

Mr. Valdez will be presenting a resolution to the board soon regarding residents currently using septic systems to hook up to the city sewer system. Possibly the tap fee could be waived for these individuals. Mr. Valdez hopes to have a draft at the next meeting.

Mr. Graber, RJH, is working on a proposal for the Hicklin Ditch, but Mr. Valdez wants to wait to act on it until the final cost of the possible law suit is in. When the due diligence was done for the proposed dam there were 2 objectors, Mr. Ken Danylchuk and Mr. Jim Ruby, and dealing with them may be expensive. Mr. Valdez wants to freeze all capital projects until he gets an estimate from the attorney's office on the cost of this lawsuit.

June 13, 2013, 6 pm at Table Mountain Church in Rye Mr. Valdez will be meeting with the Town of Rye and all landowners along the creek to start the process of protecting the water source for our area. Colorado Rural Water will help set up a source water plan and a state grant will be applied for to pay for the process.
