RESOLUTION 2-2015

**A RESOLUTION AMENDING CERTAIN RATE AND FEE SCHEDULES
CONTAINED IN RESOLUTION NO. 1-2000, ADOPTED 8 FEBRUARY, 2000**

WHEREAS, after due consideration and deliberation, the Board of Directors of the Colorado City Metropolitan District hereby declare that some rate and fee schedules contained in Resolution No. 1-2000, adopted on 8 February, 2000, to be null and void, and,

WHEREAS, in order to balance the Calendar year 2015 budget, the Board of Directors hereby resolves to increase/decrease certain rates and fees for the year 2015, and,

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

All rate changes are effective January 1, 2015, with the exception of average winter consumption wastewater rates, which will go into effect March 1, 2015.


